11. There will be no requirement of filing applications for personal exemption of the Complainant and / or Accused in criminal matters.
12. To avoid excess crowd in the Court Office/Registry, the Advocates are requested to ensure that the Affidavits and/ or Verification of pleadings are duly affirmed, before a Notary.
13. Where parties have to file Statement on Oath (in Inventories) and/or Indemnity Bonds_ (like in the case of release of property), and/or Consent terms, the same shall be signed/executed before a Notary.
14. In matters fixed for Final Arguments, the Advocates are encouraged to advance their oral submissions via Video Conference, within the time available.
15. A soft copy of this Cause list will be shared with the President of the Mapusa Advocates Forum, for further circulation amongst the Bar Members. No hard copy of the Board will be available in the Court Room.
16. Inspection of the Court files is strictly prohibited by Advocates or parties.
17. No lawyer will be allowed entry into the Court premises and/or Court Hall for the purpose of mentioning.
